Personal data that we process

GROWN bio BV processes your personal data because you use our services and / or because you provide this information to us yourself.

Below you will find an overview of the personal data that we process:

- First and last name
- Address data
- Telephone number
- E-mail address
- IP address
- Information about your activities on our website
- Internet browser and device type
- Bank account number

Special and / or sensitive personal data that we process

Our website and / or service does not intend to collect data about website visitors under the age of 16. Unless they have permission from their parents or guardian. However, we cannot check whether a visitor is older than 16. We therefore advise parents to be involved in the online activities of their children, in order to prevent data about children from being collected without parental consent. For what purpose and on what basis we process personal data

GROWN bio BV processes your personal data for the following purposes:

- Handling your payment
- Sending our newsletter and / or advertising brochure
- To be able to call or e-mail you if necessary to carry out our services
- To inform you about changes to our services and products
- To offer you the possibility to create an account
- To deliver goods and services to you
- GROWN bio BV also processes personal data if we are legally obliged to do so, such as information that we need for our tax return.

Automated decision-making

GROWN bio BV takes decisions based on automated processing on matters that can have (significant) consequences for people. These are decisions taken by computer programs or systems, without involving a person (for example, an employee of GROWN bio BV). GROWN bio BV uses the following computer programs or systems: Hubspot, Woocommerce en E boekhouden.

How long do we keep personal data?

GROWN bio BV does not store your personal data longer than is strictly necessary to achieve the purposes for which your data is collected. We use the following retention periods for the following (categories) of personal data: differs, depends on the computer program.

Sharing of personal data with third parties

GROWN bio BV shares your personal data with various third parties if this is necessary for the execution of the agreement and to comply with any legal or contractual obligation. We conclude a processor agreement with companies that process your data on our behalf to ensure the same level of security and confidentiality of your data. GROWN bio BV remains responsible for these processing operations. GROWN bio BV also provides your personal data to other third parties. We only do this with your explicit permission.

GROWN bio BV shares only strictly necessary personal data to carriers.

View, modify or delete data

You have the right to view, correct or delete your personal data. You also have the right to withdraw your consent to the data processing or to object to the processing of your personal data by GROWN bio BV and you have the right to data portability. This means that you can submit a request to us to send the personal data that we have about you in a computer file to you or another organization mentioned by you.

You can send a request for access, correction, deletion, data transfer of your personal data or request for cancellation of your consent or objection to the processing of your personal data to jan@grown.bio.

To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen Service Number (BSN) black in this copy. This is to protect your privacy. We will respond to your request as soon as possible, but within four weeks.
